I, Rustim Keraan, Director: Solid Waste Management, City of Cape Town, hereby in terms of the provisions of the City of Cape Town's Integrated Waste Management By-law (2009) accredit: **C AND E LOGISTICS CC** to operate as a Waste Service Provider in the Cape Town Municipal area.

This accreditation applies only to the listed waste management operational activities as contained in your application and will be revoked should **C AND E LOGISTICS CC** breach any applicable national or provincial legislation or the City's by-laws which results in prosecution or conviction in a court of law, or should substantive changes to processes, equipment or waste management occur, upon which a new accreditation application must be submitted. The onus is on the Accredited Waste Services Provider to provide the City with information relating to any prosecutions or convictions in terms of other applicable legislation or information relating to substantive operational changes.

This accreditation as a Waste Services Provider is based on the listed activities per the attachment addendum; it is not transferable through a change in ownership or relocation of premises. Accreditation does not automatically confer any contractual status between the City of Cape Town and the Accredited Waste Service Provider.

This accreditation does not exempt the Accredited Waste Service Provider from the responsibilities and obligations arising out of any other applicable legislation.

Note: This accreditation is valid for twenty four (24) months calculated from the date of signature of the accreditation. Onus lies on the applicant to apply for renewal within the accreditation validity period or to seek accreditation should activities, as listed in the attached addendum, be extended or amended, whichever is soonest. To allow for official purposes you should submit your renewal application documentation at least 60 calendar days prior to the expiry date.
